## Emergency Overview

**Physical Description & Colour:** Pale yellow liquid.

**Odour:** Pungent.

**Major Health Hazards:** Causes serious eye damage. May cause respiratory irritation.

**Inhalation:** Breathing in mists will produce respiratory irritation.

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other nonhazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

## Section 4 – First Aid Measures

**General Information:** You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 11 26 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

**Inhalation:** If irritation occurs, contact a Poisons Information Centre, or call a doctor. Remove source of contamination or move victim to fresh air. If breathing is difficult, oxygen may be beneficial if administered by trained personnel, preferably on a doctor's advice. In severe cases, symptoms of pulmonary oedema can be delayed up to 48 hours after exposure.

**Skin Contact:** Wash gently and thoroughly with warm water (use non-abrasive soap if necessary) for 10-20 minutes or until product is removed. Under running water, remove contaminated clothing, shoes and leather goods (e.g. watchbands and belts) and completely decontaminate them before reuse or discard. If irritation persists, repeat flushing and seek medical attention.

**Eye Contact:** Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for 20 minutes or until the product is removed, while holding the eyelid(s) open. Take care not to rinse contaminated water into the unaffected eye or onto the face. Obtain medical attention immediately. Take special care if exposed person is wearing contact lenses.

**Ingestion:** If swallowed, do NOT induce vomiting. Wash mouth with water and contact a Poisons Information Centre, or call a doctor.

## Section 6 – Accidental Release Measures

---

**Personal Precautions:** Isolate area. Keep unnecessary personnel away. Stay upwind. Ventilate closed spaces before entering. Do not touch or walk through spilled material. Wear appropriate protective equipment and clothing during clean-up. Absorb the spilled material with an inert absorbent (non-flammable) material.

**Environmental Precautions:** Prevent entry into waterways, sewers, basements or confined areas.

**Clean-up Procedures:** Eliminate ignition sources including sources of electrical, static or frictional sparks.

Small Spills: Use a non-combustible material to soak up the product and place into a container for later disposal.

Large Spills: Dike far ahead of liquid spill for later disposal.

## Section 7 – Handling and Storage

---

Classified as a C1 (Combustible liquid) for the purpose of storage and handling, in accordance with the requirements of AS 1940.

**Precautions for safe handling:** Avoid skin and eye contact and breathing in vapour.

**Storage Conditions:** Store in a cool, dry, well ventilated place and out of direct sunlight. Store away from incompatible materials described in Section 10. Store away from sources of heat or ignition. Keep containers closed when not in use - check regularly for leaks.
